- The school will provide well equipped Laboratories, Library and other facilities as per norms of the Board. The 6. relevant books as per the academic level of students shall be made available in the library.
- The School should have at least one adequately equipped computer lab with a minimum of 10 computers and would ensure computer student ratio of 1:20 at least. Proper software along with facility of Broad Band 7. connectivity with the feature of 'internet always on' from any service provider to be ensured.
- The schools affiliated and running upto Senior Secondary Level will provide suitable facilities including the equipment in laboratories/workshops and games for classes XI and XII as per requirements laid down in rules. 8.

- 36. The school will create Reserve Fund as per the requirement of the Affiliation Bye Laws.

- 41. The school shall apply for further Extension of General Affiliation 'Online' through www.cbseaff.nic.in with prescribed fee and other essential documents as per the time period given by the board in this regard before the expiry of the date of General affiliation otherwise penalty as per rules will be charged for late execution of application.
- 42. The school should not start Class IX/X/XI/XII (as the case may be) without written approval of the Board. The Board shall not be responsible for any consequences in case class IX/X/XI/XII are started without obtaining the prior approval of the Board and without following the Affiliation Byelaws.
- 43. It is mandatory for every affiliated school to become a member in the local Sahodaya of CBSE schools.

In case of non compliance of the these conditions the school will be liable for action as per rules:-

- * The school has now submitted the size of reconstructed class rooms as No. of class rooms=22 ($26 \times 22 = 572 \text{ sq.ft.}$), Library($61.5 \times 22 = 1353 \text{ sq.ft.}$) and idath lab ($41 \times 22 = 902 \text{ sq.ft.}$), duly verified by the inspection committee who inspected the school. However the IC put a remark on the the verification of infrastructure details that due to Covid-19 pandemic IC members were not able to travel to the school to physically verify the reconstructed rooms but they verified the video coverage of day by day demolition of the walls and the reconstructed class rooms, sent by school. Therefore, the school is granted the Affiliation subject to the condition that the infrastructure of the school can be verified at any time or at the time of further upgradation of affiliation.
- * The school is required to remit a sum of Rs.100000/- in the shape of D.D. in favor of Secretary, CBSE, Delhi towards using the name of CBSE in all its safety certificates prior to grant of Affiliation.
- * The number of section of the school shall be restricted to 22 as per the number of class rooms reported during inspection & further increase shall be subject to specific approval of the Board on the basis of the request of the school as per Affiliation Bye Laws.
- * The school is required to upload a commencement certificate as per appendix VIII of the existing affiliation bye laws, within three months through the online link provided for the purpose, furnishing details of compliance(s) made in response to the condition(s) in the grant letter.
